<u>077-17-030</u> The following resolution was offered by Ms. Sabin, who moved its adoption, seconded by Mr. Dudzinski, to wit:

**WHEREAS**, pursuant to the provisions of the Municipal Home Rule Law, proposed Local Law No. C-2017, Amending Chapter 200 of the Code of the Town of Van Buren titled "Zoning", amending the regulations for the Planned Unit Development District to include a fee in lieu of parkland, was presented and introduced at a regular meeting of the Town Board of the Town of Van Buren held on April 4, 2017; and

WHEREAS, a public hearing was held on such proposed local law on this 18th day of April, 2017, by the Town Board of the Town of Van Buren and proof of publication of notice of such public hearing, as required by law, having been submitted and filed, and all persons desiring to be heard in connection with said proposed local law having been heard, and said proposed local law having been in the possession of the members of the Town Board of the Town of Van Buren in its final form in the manner required by Section 20 of the Municipal Home Rule of the State of New York; and

**WHEREAS**, on April 4, 2017 the enactment of Proposed Local Law No. C-2017 was determined to be an unlisted action and will have no significant effect on the environment thus concluding the SEQR review process; and

**WHEREAS**, it is in the public interest to enact said Proposed Local Law No. C-2017. **NOW, THEREFORE**, it is

**RESOLVED AND DETERMINED** that the Town Board of the Town of Van Buren, Onondaga County, New York, does hereby enact proposed Local Law No. C-2017 as Local Law No. 2-2017 as follows:

# LOCAL LAW NO. 2-2017 TOWN OF VAN BUREN

**BE IT ENACTED** by the Town Board of the Town of Van Buren that this local law amends Chapter 200 of the Code of the Town of Van Buren, as follows:

#### Section 1.

So that a new Section 200-33(B)(8) shall be added to the Town of Van Buren Zoning Regulations, which shall read, in its entirety, as follows:

"(8) The Planning Board may, in its discretion and upon evaluation of the present and anticipated future needs for the park and recreational facilities in the Town based upon projected population growth attributable to the residential portion of any planned unit development, render a finding that a proper case exists for requiring that a park or parks be suitably located for playgrounds or other recreational purposes with the Town. In the event the Planning Board makes such a finding but further determines that a suitable park or parks of adequate size to meet the requirement cannot be properly located within such district, the Town Board may require a sum of money in lieu thereof, in an amount to be established by the Town

Board. In making a determination of suitability, the Planning Board shall assess the size and suitability of lands shown on the site plan which could be possible locations for park or recreational facilities, as well as practical factors, including whether there is a need for additional facilities in the immediate neighborhood. Any moneys required by the Town Board in lieu of land for park, playground or other recreational purposes, shall be deposited into a trust fund to be used by the Town exclusively for park, playground or other recreational purposes, including the acquisition of property."

## Section 2.

This Local Law shall take effect upon its filing with the New York Secretary of State.
