Mr. Sykes said due to social distancing in place because of Covid-19 we are restricted to six members of the public in the boardroom. Mr. Lee Tetu, Commane Road, asked to speak. He said he saw this item on the agenda and is concerned about anything that may infringe on a property owner's rights. He asked how far this law goes. He said he looked at the photos from the presentation on the website and there are some that could use a fence, but he wouldn't cite them. He asked if he goes on vacation and his lawn isn't not mowed will he come home to a violation notice on his door? He said this needs to be available and defined before the hearing.

Mr. Sykes said the local law will be available on the town's website tomorrow.

Ms. Sabin said the Land Use Committee has been working on this since last July. She said they looked at other town's codes, NYS Code and took resident complaints into consideration when crafting it.

Ms. Lesniak said the law is reactive and not proactive. She said the Board is looking to balance property owners' rights and how to address the complaints received from residents.

112-20-039 Councilor Dudzinski introduced proposed Local Law No. A-2020, "A Local Law to Repeal and Replace Chapter 145 of the Code of the Town of Van Buren Relative to Property Maintenance and Controlling Junk", which Local Law would establish regulations designed to prevent unhealthy, hazardous or unsightly conditions due to accumulations of yard waste, weeds, junk, garbage, rubbish, clutter, litter and debris on improved property in order to protect the public health, safety and general welfare of the residents of the Town, and made the following motion, which was seconded by Councilor Sabin,

WHEREAS, Volume 6 N.Y.C.R.R., Section 617 of the Regulations relating to Article 8 of the New York State Environmental Conservation Law, requires that as early as possible an involved agency shall make a determination whether a given action is subject to the aforementioned law; and

WHEREAS, no other agency has the legal authority or jurisdiction to approve or directly undertake the enactment of a local law in the Town of Van Buren; and

WHEREAS, the Town Board has determined that a short environmental assessment form (EAF) shall be required in connection with this matter; and

WHEREAS, the said EAF has been prepared and has been reviewed by the Town Board; and

WHEREAS, the Town Board has considered the adoption of said Local Law, has considered the criteria contained in 6 N.Y.C.R.R. Part 617.7 and has compared the impacts which may be reasonably expected to result from the adoption of said Local Law against said criteria.

NOW, THEREFORE,

RESOLVED AND DETERMINED, there are no other involved agencies within the meaning of the New York State Environmental Quality Review Act (SEQRA) with respect to the proposed enactment of said Local Law, with the result that the Town Board shall act as lead agency in this matter; and it is further

RESOLVED AND DETERMINED, the adoption of said Local Law is an unlisted action for purposes of environmental review under SEQRA; and it is further

RESOLVED AND DETERMINED, the Town Board has determined this action shall have no significant adverse impact on the environment; that, accordingly, an environmental impact statement (EIS) shall not be required; and that this resolution shall constitute a negative declaration under SEQRA; and it is further

RESOLVED, that the Town Board shall conduct a public hearing as to the enactment of proposed Local Law No. A-2020 at the Van Buren Town Hall, 7575 Van Buren Road, Baldwinsville, New York 13027, on September 1, 2020 at 7:00 p.m. or as soon thereafter as the matter can be heard, at which time all persons interested in the subject shall be heard.
