Approve removal of unsafe structure at 1672 Old Rt. 31: 149-23-000

The following resolution was offered by Councilor Van Der Water who moved its adoption, seconded by Councilor Sullivan, to wit:

WHEREAS, in accordance with Article I of Chapter 96 of the Town of Van Buren Town Code, as amended, a hearing was conducted on August 2, 2023, for purposes of receiving and considering evidence presented by Christopher Perdue, the Town of Van Buren Code Enforcement Officer (hereinafter "CEO Perdue"), to determine whether the structure situated on real property located at 1672 Old Route 31, Tax Map No. 047.-01-08.0, in the Town of Van Buren ("Property") is "dangerous" or "unsafe;" and

WHEREAS, legal counsel for the Town of Van Buren confirmed the issuance of the "Notice of Unsafe Building", dated July 19, 2023, such Notice having been duly filed in accordance with Section 96-5(A) of the Town of Van Buren Town Code with the Onondaga County Clerk's Office on July 31, 2023, Index No. 2023-00000527; and

WHEREAS, an affidavit of service by Sheri Schmedicke of the notice of the hearing upon Michael C. Stone, owner of the Property, was duly filed with the Onondaga County Clerk's Office; and

WHEREAS, during the public hearing, CEO Perdue presented a report he prepared, dated May 10, 2023, documenting the unsafe condition of the Property and the efforts made by the Town to obtain voluntary compliance; and

WHEREAS, CEO Perdue reported to the Town Board that the residential structure on the Property was significantly damaged, citing the collapse of the roof and rear wall, the structural concerns with the eastern wall, and the compromised condition of the foundation block wall on the east and south sides of the structure; and

WHEREAS, CEO Perdue confirmed that, as the Code Enforcement Officer for the Town of Van Buren, it is his opinion that the condition of the Property is unsafe and dangerous in accordance with Chapter 96 of the Town Code; and

WHEREAS, CEO Perdue opined that the residential structure, which exhibits significant structural damage, is in an unsafe condition and is dangerous to the health, safety and general welfare of the public; and

WHEREAS, although Mr. Stone has been in communication with the Code Enforcement Office and has written to the "Building and Code Officer" acknowledging the need for and consent to the structure's demolition, Mr. Stone did not attend the due process hearing, nor did anyone appear on his behalf; and

WHEREAS, the Town Board closed the public hearing; and

WHEREAS, it is the desire of the Town Board to undertake any and all measures permitted in the Town Code that are necessary to protect the public's health, safety and welfare.

NOW THEREFORE, BE IT RESOLVED that the Town Board, having duly considered the documentary evidence and oral testimony presented by the Code Enforcement Officer, hereby declares the property located at 1672 Old Route 31, Tax Map No. 047.-01-08.0, to be dangerous and unsafe; and

BE IT FURTHER RESOLVED, that the Town Board, having duly declared the Property dangerous and unsafe, hereby orders the owner or persons with an interest in such Property to demolish and remove the existing residential structure and clear the Property of any and all demolition debris and all excavations filled and graded, so as to comply with the Town of Van Buren Town Code; and

BE IT FURTHER RESOLVED, that such corrective action must occur within thirty (30) days of the date of mailing this Declaration and Order; and

BE IT FURTHER RESOLVED, that in the event corrective action does not occur within the time provided, the Town Board hereby authorizes the Code Enforcement Office to undertake any and all such measures as are necessary to effectuate the demolition and removal of the structure, which shall include the excavation and leveling of the Property; and

BE IT FURTHER RESOLVED, that the Code Enforcement Officer shall file with the Town Board a verified statement of all expenses for the cost of such demolition, excavation and grading if undertaken by the Town of Van Buren, and such costs shall be charged to and reimbursed by the owner of the Property and shall be assessed against the land upon which the structure is located and shall constitute a lien; and

BE IT FURTHER RESOLVED, that notice of the Town Board's Declaration and Order shall be issued in accordance with Section 96-6 of the Town Code.
