WHEREAS, pursuant to the provisions of the Municipal Home Rule Law, a proposed local law titled, a Local Law No. D of 2022 "Amending the Annual Income Ranges for Senior Citizens and Disabled Persons as set forth in Chapter 180 of the Town Code," was presented and introduced at a regular meeting of the Town Board of the Town of Van Buren held on December 7, 2022; and

WHEREAS, no other agency has the legal authority or jurisdiction to approve or directly undertake the enactment of a local law in the Town of Van Buren, such that there are no other involved agencies within the meaning of the New York State Environmental Quality Review Act (SEQR) with respect to the proposed enactment of said Local Law, with the result that the Town Board shall act as lead agency in this matter; and

WHEREAS, that the enactment of proposed Local Law No. D of 2022 is an Unlisted action and, as a local law amending the annual income ranges for tax exemption eligibility will have no significant effect on the environment, thus concluding environmental review under SEQR; and it is further

WHEREAS, a public hearing was held on such proposed Local Law on the 21st day of December, 2022 by the Town Board of the Town of Van Buren and proof of publication of notice of such public hearing, as required by law, having been submitted and filed, and all persons desiring to be heard in connection with said proposed Local Law having been heard, and said proposed Local Law having been in the possession of the members of the Town Board of the Town of Van Buren in its final form in the manner required by Section 20 of the Municipal Home Rule of the State of New York; and

WHEREAS, it is in the public interest to enact said Proposed Local Law No. D of 2022.

NOW, THEREFORE, it is

RESOLVED AND DETERMINED, that the enactment of Proposed Local Law No. D of 2022 is an unlisted action that there are no other involved agencies, that this Board will act as lead agency for this application and further, rendered a negative declaration for purposes of SEQR; be it further

RESOLVED AND DETERMINED, that proposed Local Law D of 2022 is hereby enacted as Local Law No. 4 of 2022, as follows:

"TOWN OF VAN BUREN PROPOSED LOCAL LAW NO. 4 of 2022

A Local Law Amending the Annual Income Ranges for Senior Citizens and Disabled Persons as set forth in Chapter 180 of the Town Code

Be it enacted by the Town of Van Buren Town Board, as follows:

Section 1.

So that the annual income ranges for persons 65 years of age or over as listed in Section 180-5(A) of the Town of Van Buren Town Code, titled "Exemption provided," shall be revised, in its entirety, as follows:

"Annual Income Ranges	Exemption Percentage
Less than \$29,000.00	50%
More than \$29,000.01 but less than \$29,999.99	45%
More than \$30,000.00 but less than \$30,999.99	40%
More than \$31,000.00 but less than \$31,999.99	35%
More than \$32,000.00 but less than \$32,899.99	30%
More than \$32,900.00 but less than \$33,799.99	25%
More than \$33,800.00 but less than \$34,699.99	20%

"Annual Income Ranges	Exemption Percentage
More than \$34,700.00 but less than \$35,599.99	15%
More than \$35,600.00 but less than \$36,499.99	10%
More than \$36,500.00 but less than \$37,399.99	5%"

Section 2.

So that the annual income ranges for disabled persons as listed in Section 180-8 of the Town of Van Buren Town Code, titled "Exemption provided," shall be revised, in its entirety, as follows:

"Annual Income Ranges	Exemption Percentage

More than \$29,000.01 but less than \$29,999.99	45%
More than \$30,000.00 but less than \$30,999.99	40%
More than \$31,000.00 but less than \$31,999.99	35%

More than \$33,800.00 but less than \$34,699.99	20%

Introduction of Local Law E-2022:

187-22-039 Mrs. Van Der Water introduced proposed Local Law No. E-2022, revising the term and residency requirements for the Town of Van Buren Comptroller position and made the following motion, which was seconded by Mr. Hulchanski

WHEREAS, this Local Law shall supersede Public Officers Law § (3)(1); and

WHEREAS, as proposed, the amendment of Section 13-2 of the Town of Van Buren Town Code will amend the term of the Comptroller from four (4) years to two (2) years, and the amendment to Section 13-3 will allow the person holding the position of Town Comptroller to be a resident or elector of the County of Onondaga or an adjacent county; and

WHEREAS, no other agency has the legal authority or jurisdiction to approve or directly undertake the enactment of Local Laws in the Town of Van Buren, such that there are no other involved agencies within the meaning of the New York State Environmental Quality Review Act (SEQR) with respect to the proposed enactment of said Local Law, with the result that the Town Board shall act as lead agency in this matter; and

WHEREAS, the adoption to said Local Law is an unlisted action for purposes of environmental review under SEOR; and

WHEREAS, the Town Board has determined that a short environmental assessment form (EAF) shall be required in connection with this matter; and

WHEREAS, the said EAF has been prepared and has been reviewed by the Town Board; and

WHEREAS, the Town Board has considered the adoption of said Local Law, has considered the criteria contained in 6 N.Y.C.R.R. Part 617.7 and has compared the impacts which may be reasonably expected to result from the adoption of said Local Law against said criteria.

NOW, THEREFORE, IT IS

RESOLVED AND DETERMINED that the enactment of this proposed local law is an unlisted action under SEQR, that there are no other involved agencies, and the Town Board shall act as lead agency; and it is further

RESOLVED AND DETERMINED, the Town Board has determined this action shall have no significant adverse impact on the environment; that, accordingly, an environmental impact statement (EIS) shall not be required; and that this resolution shall constitute a negative declaration under SEQR; and it is further

RESOLVED AND DETERMINED that the Town Board shall conduct a public hearing as to the enactment of proposed Local Law No. E-2022 at the Van Buren Town Offices located at 7575 Van Buren Road in the Town of Van Buren on January 4, 2023, at 7:00 p.m. or as soon thereafter as the matter can be heard, at which time all persons interested on the subject shall be heard.
