#### Approve Local Law B-2023:

<u>048-23-030</u> The following resolution was offered by Mrs. Sullivan who moved its adoption, seconded by Mrs. Van Der Water to wit:

**WHEREAS**, pursuant to the provisions of the Municipal Home Rule Law and the Real Property Tax Law § 466-a, a proposed local law titled, a Local Law No. B of 2023 "A Local Law Amending Article VI of Chapter 180 of the Town of Van Buren Town Code to Continue the Property Tax Exemption for Volunteer Firefighters and Ambulance Workers Pursuant to Real Property Tax Law § 466-a," was presented and introduced at a regular meeting of the Town Board of the Town of Van Buren held on February 1, 2023; and

**WHEREAS**, a public hearing was held on such proposed Local Law on the 15<sup>th</sup> day of February, 2023 by the Town Board of the Town of Van Buren and proof of publication of notice of such public hearing, as required by law, having been submitted and filed, and all persons desiring to be heard in connection with said proposed Local Law having been heard, and said proposed Local Law having been in the possession of the members of the Town Board of the Town of Van Buren in its final form in the manner required by Section 20 of the Municipal Home Rule of the State of New York; and

**WHEREAS**, the enactment of Proposed Local Law No. B-2023 has previously been determined to be an Unlisted Action and will have no significant adverse impact on the environment thus concluding the SEQR review process; and

WHEREAS, it is in the public interest to enact said Proposed Local Law No. B of 2023. NOW, THEREFORE, it is

**RESOLVED**, that the Town Board of the Town of Van Buren, Onondaga County, New York, does hereby enact proposed Local Law No. B of 2023 is hereby enacted as Local Law No. 2 of 2023, as follows:

#### "Town of Van Buren Local Law No. 2 of 2023

A Local Law Amending Article VI of Chapter 180 of the Town of Van Buren Town Code to Continue the Property Tax Exemption for Volunteer Firefighters and Ambulance Workers Pursuant to

Be it enacted by the Town of Van Buren Town Board, as follows:

#### Section 1.

So that Article VI of the Town of Van Buren Town Code, titled "Exemption for Volunteer Firefighters and Ambulance Workers," is hereby amended pursuant to Real Property Tax Law Section 466-a, so that Article VI shall read in its entirety as follows:

"§ 180-10.1 Legislative Intent.

Having previously enacted an exemption on real property taxes for certain volunteer firefighters and ambulance workers pursuant to Real Property Tax Law § 466-g, it is the intent of the Town

Board of the Town of Van Buren to continue to provide a real property tax exemption to qualifying volunteer firefighters and ambulance workers and conform to the new Statewide exemption as set forth in Real Property Tax Law § 466-a.

§ 180-10.2 Authority.

Real Property Tax Law § 466-a authorizes the Town Board to adopt a local law providing a real property tax exemption of up to ten percent (10%) of the assessed value of real property owned by the qualifying volunteer firefights and ambulance workers.

§ 180-10.3 Grant of exemption.

An exemption of ten percent (10%) of assessed value of property owned by an enrolled member as set forth below, or such enrolled member and their spouse, is hereby granted from taxation with respect to the real property taxes of the Town of Van Buren as long as eligibility requirements are met.

§ 180-10.4 Eligibility requirements.

Such exemption shall be granted to an enrolled member of an incorporated volunteer fire company, fire department, or incorporated voluntary ambulance service provided that:

A. The property is owned by the volunteer firefighter or volunteer ambulance worker;

- B. The property is the primary residence of the volunteer firefighter or volunteer ambulance worker;
- C. The property is used exclusively for residential purposes;
- D. The volunteer firefighter or volunteer ambulance worker resides in the Town of Van Buren and the Town of Van Buren is served by such incorporated volunteer fire company or fire department or incorporated voluntary ambulance service;
- E. The volunteer firefighter or volunteer ambulance worker is certified by the authority having jurisdiction as an enrolled member of such an incorporated volunteer fire company, fire department, or incorporated voluntary ambulance service; and
- F. The volunteer firefighter or volunteer ambulance worker meets the minimum service requirement established by the Town of Van Buren, which is hereby established as five (5) years.

§ 180-10.5 Application.

A volunteer firefighter or volunteer ambulance worker must annually, on or before the applicable taxable status date, file an application for such property tax exemption with the assessor responsible for preparing the assessment roll for the Town of Van Buren, on a form as prescribed

by the New York State Commissioner of Taxation and Finance. The Town of Van Buren must maintain written guidelines, available upon request, as to the requirements of an enrolled volunteer member relating to this exemption.

### § 180-10.6 Certification.

The Town of Van Buren Town Board must annually file with the Town Assessor, prior to the applicable taxable status date, a list of the active volunteer members who are certified to meet the minimum service requirement. Such list must provide, as of the applicable taxable status date, the number of years of service served by each such enrolled member and such enrolled member's address of residence.

#### § 180-10.7 No diminution of benefits.

An applicant who is receiving any benefit pursuant to Article 4 of the Real Property Tax Law as of the effective date of this Article shall not have any of those benefits diminished because of this Article.

§ 180-11 Lifetime and un-remarried spouse exemptions.

- A. Any eligible enrolled member who accrues more than 20 years of active volunteer service (as certified by the authority having jurisdiction) shall be granted the ten percent (10%) exemption as authorized by this Article for the remainder of his or her life as long as his or her primary residence is located within the Town of Van Buren.
- B. The un-remarried surviving spouse of a deceased enrolled member killed in the line of duty, as certified by the authority having jurisdiction, is qualified to continue to receive an exemption, as long as the deceased volunteer had been an enrolled member for at least five (5) years and had been receiving the exemption at the time of his or her death."

Section 2. Validity and Severability.

If any clause, sentence, paragraph, section, or part of this Local Law is declared by a Court of competent jurisdiction to be invalid, such judgment shall not affect, impair or invalidate the remainder thereof, but shall be confined in its operation to said clause, sentence, paragraph, section or part of this Local Law.

Section 3. Effective Date.

This Local Law shall take effect immediately upon filing in the office of the Secretary of State in accordance with Municipal Home Rule Law Section 27. Roll Call Votes: Mrs. Sullivan – Yes, Mr. Hulchanski – Yes, Mrs. Van Der Water – Yes, Mr. Tupper – Yes, Ms. Sabin – Yes

## Attorney Comments: None

Mrs. Van Der Water asked Ms. Golden to discuss her February report for the Board.

Ms. Golden said the confirmed trends for the 2023 Assessment Roll are residential +5%, commercial +5% and vacant +8%. The LOA and Equalization Rate is projected to be 95% for 2023.

The 2023 Assessment Roll timeline will be as follows: All changes to assessments or inventory by March 31 Tentative change of assessment notices mailed by April 17 Informal meetings with the assessor the week of April 24 and May 1<sup>st</sup> Tentative roll filed on or before May 1<sup>st</sup> Grievance Day by appointment on Tuesday May 23

Ms. Golden discussed the following changes and information for Real Property Legislation in 2022:

Senior Citizen and persons with disabilities increase of income limits on sliding scale to maximum of 50,000.

Town of Van Buren raised income limit to 37,400 (matches county)

Senior Citizen exemptions requirement for second notice.

Town of Van Buren Assessor's office mailed second notice to all property owners with Enhanced Star and not the Senior Citizen exemption.

Volunteer firefighters and ambulance workers exemption statewide option.

Town of Van Buren holding public hearing on changing to statewide option.

Ms. Golden said the Exemption Administration 2022 Summary is attached.

Ms. Golden said she earned 36 hours of continuing education credits during 2022 and the warnings have been removed. Requirements met for 2021, 2022 and 2023. The Continuing Education Status Report is attached
