Assessor's Report:

Ms. Golden said the 2018 budget changes included making Enhanced Star Income Verification mandatory beginning in 2019. Multiple forms are required in 2019 for Senior Citizen exemptions, Enhanced Star exemptions and the MANDATORY IVP form. Assessor's have the option to mail the IVP forms to ORPTS for input into the state database. We will be imputing the information directly into the database from the submitted forms. We decided that this would be the best approach and would better serve our senior property owners.

Regular Town Board Meeting February 19, 2019

Reminder postcards were mailed to 200 property owners who have yet to renew their Enhanced Star and/or Sr Citizen Exemption. The deadline to renew or apply for all exemptions is March 1st.

Reappraisal work completed for 2019 includes nine residential neighborhoods. Trending assessments will be completed for an additional 3 neighborhoods. Commercial reappraisals will be completed for all properties reappraised in 2013 or 2014 with median values less than median county sale values. Vacant land with physical changes in 2018 will also be reappraised.

All documents required for the 2019 NRR plan were submitted to ORPTS on January 31st. The deadline for plan documents was February 1.

Physical changes to inventory and assessments are completed as permits are finished. Final field review for all incomplete permits will be scheduled the week of March 1^{st.} (taxable status date)

The Town of Lysander Exemption Audit Report has been released and the following is a review of findings:

32 Agricultural exemptions were reviewed:

Original application for each ag land exemption which should include Soil Group Worksheet and Map.

2017 renewal application for each Ag land exemption which should include current lease if applicable and proof of income.

Soil group worksheets were also reviewed and compared to computer entered soil group data for accuracy.

The results were one original Ag land application submitted in 1995 was missing soil map.

1 greenhouse application submitted in 2000 was missing.

1 Ag land renewal was missing a current lease.

25 Senior Citizen Exemptions were reviewed:

Original application for each senior citizen exemption which should include proof of age and income.

2017 renewal application for each senior citizen exemption which should include proof of income.

Income was totaled and percent discount calculated for each senior citizen exemption. The income and percent discount numbers were compared to computer entered numbers for accuracy.

The results were one original senior citizen application submitted in 2017 was missing proof of age.

One exemption percentage (for school only) was wrong as income scale for wrong school district was used in error.

One error in totaling income

Two errors entering percent discount into computer.

59 Veterans Exemptions: Which included four different types of Veteran exemptions:

Original application for each Veterans exemption and supporting documentation required for each type of exemption.

Applications and supporting documentation was reviewed and compared to computer entered exemption information and accuracy.

The results were one eligible funds Veteran exemption application submitted in 1994 was missing.

Four Veteran exemptions indicated honorable service on the DD214 form but were missing the section containing honorable discharge information.

One alternative Veteran exemption application submitted in 2000 incorrectly received an extra 10% for combat service and DD214 did not indicate combat service. Further review of exemption file included a letter from the Department of The Air Force received in 2003 that indicated receipt of Expeditionary Medal. This automatically counts for extra 10% combat service. Exemption was granted correctly but is listed as an exception in the Audit Report, because of timing.

One Alternative Veteran exemption application submitted in 2002 contained a veteran disability rating letter submitted in 2008 which was attached to the original application. Disability rating earned an extra 15% discount which was not applied due to clerical error. Please note: The correct Veteran Disability percentage discount was applied for the 2019 Assessment Roll. A correction of errors form for three years of refunds was submitted by the Assessor for County approval per RPTL.
