WHEREAS, pursuant to the provisions of the Municipal Home Rule Law, a proposed local law titled "A Local Law Amending Chapter 58 of the Town Code of the Town Code of the Town of Van Buren, titled "Residency Requirements," with Respect to the Position of Town Historian," was presented and introduced at a regular meeting of the Town Board of the Town of Van Buren held on February 7, 2024; and

WHEREAS, a public hearing was held on such proposed local law on this 21st day of February, 2024, by the Town Board of the Town of Van Buren and proof of publication of notice of such public hearing, as required by law, having been submitted and filed, and all persons desiring to be heard in connection with said proposed local law having been heard, and said proposed local law having been in the possession of the members of the Town Board of the Town of Van Buren in its final form in the manner required by Section 20 of the Municipal Home Rule of the State of New York; and

WHEREAS, the enactment of proposed Local Law No. C-2024 has previously been determined to be an unlisted action and will have no significant effect on the environment thus concluding the SEQR review process; and

WHEREAS, it is in the public interest to enact said proposed Local Law No. C-2024. NOW, THEREFORE, it is

RESOLVED that the Town Board of the Town of Van Buren, Onondaga County, New York, does hereby enact proposed Local Law No. C-2024 as Local Law No. -2024 as follows:

"TOWN OF VANBUREN LOCAL LAW C -2024

A LOCAL LAW AMENDING CHAPTER 58 OF THE TOWN CODE OF THE TOWN OF VAN BUREN, TITLED "RESIDENCY REQUIREMENTS," WITH RESPECT TO THE POSITION OF TOWN HISTORIAN

BE IT ENACTED by the Town Board of the Town of Van Buren that this Local Law amends Chapter 58 of the Code of the Town of Van Buren, as follows:

SECTION 1. LEGISLATIVE PURPOSE AND INTENT.

The Town Board of the Town of Van Buren adopts this Local Law to establish residency requirements for the appointed position of Town Historian of the Town of Van Buren.

SECTION 2. AUTHORITY.

This local law is enacted pursuant to the New York State Constitution and New York Municipal Home Rule Law § 10(1)(ii))(a)(1) that grants to local governments the authority to enact local laws regarding the qualifications of local officers. Furthermore, this Local Law recognizes that the State Legisature previously amended Public Officers Law Article 2, § 3 expanding the residency requirements for any appointed public office, thereby rendering Public Officers Law a special law with respect to any appointed town officer (see cf N.Y. Op. Atty. Gen (Inf.) No. 2000-5).

SECTION 3. SUPERCESSION.

This Local Law shall supersede Town Law § 23(1) in its application to the office of Historian for the Town of Van Buren.

SECTION 4.

AMENDMENT OF CHAPTER 58 OF THE TOWN OF VAN BUREN TOWN CODE, TITLED "RESIDENCY REQUIREMENTS," TO ESTABLISH A NEW ARTICLE 2, SECTION 58-7 REGARDING THE RESIDENCY REQUIREMENTS FOR THE TOWN HISTORIAN.

So that a new Article 2, titled "Town Officers," with a new Section 58-7, titled "Residency, Town Historian," of the Town of Van Buren Town Code is shall hereby read, in its entirety, as follows:

"Section 58-7 Residency, Town Historian.

The person holding the office of Town Historian for the Town of Van Buren need not be a resident or elector of the Town of Van Buren provided, however, that such person shall reside in the County of Onondaga or an adjoining county with the State of New York."

SECTION 5. INCONSISTENCY.

All other local laws and ordinances of the Town of Van Buren that are inconsistent with the provision of this Local Law are hereby repealed; provided, however, that such repeal shall only be to the extent of such inconsistency and in all other respects this Local Law shall be in addition to such other local laws or ordinances regulating and governing the subject matter covered by this Local Law.

SECTION 6. SEVERABILITY.

If the provisions of any article, section, subsection, paragraph, subdivision or clause of this Local Law shall be judged invalid by a court of competent jurisdiction, such order of judgment shall not affect or invalidate the remainder of any article, section, subsection, paragraph, subdivision or clause of this Local Law.

SECTION 7. EFFECTIVE DATE.

WHEREAS, that the purpose of this Local Law is to modify the Town's regulation of Solar Power and Energy Systems, so as to support State energy policy by promoting appropriate solar development while protecting the character of the Town, valuable farmland, and local resources; and

WHEREAS, Volume 6 N.Y.C.R.R., Section 617 of the Regulations relating to Article 8 of the New York State Environmental Conservation Law, requires that as early as possible an involved agency shall make a determination whether a given action is subject to the aforementioned law; and

WHEREAS, no other agency has the legal authority or jurisdiction to approve or directly undertake the enactment of a local law in the Town of Van Buren.

NOW, THEREFORE, it is

RESOLVED AND DETERMINED, there are no other involved agencies within the meaning of the New York State Environmental Quality Review Act (SEQRA) with respect to the proposed enactment of said Local Law, with the result that the Town Board shall act as lead agency in this matter; and it is further

RESOLVED AND DETERMINED, the adoption of said Local Law is an unlisted action for purposes of environmental review under SEQRA and shall require the completion of a Short Environmental Assessment Form (EAF); and it is further

RESOLVED, that the Town Board shall conduct a public hearing as to the enactment of proposed Local Law No. A-2024 at the Van Buren Town Hall, 7575 Van Buren Road, Baldwinsville, New York, on March 6, 2024, at 7:00 p.m. or as soon thereafter as the matter can be heard, at which time all persons interested in the subject shall be heard.
