He said every application will require a variance and it has been his experience that those are rarely approved.

Mr. Zaccaria said he thinks it is better to look at each project individually and asked what Mr. Bliss would consider an appropriate setback.

Mr. Bliss said it should depend on the quality of the wetland but the town could start with 100 feet since that is the standard in New York State.

Mrs. Van Der Water said she chaired the committee that worked on this proposed local law and she said she will contact him to discuss his concerns.

Mr. Ralph Mills, State Fair Blvd., said he read through the proposed local law and was pleased to see issues like decommissioning, insurance liability and other issues were addressed. He asked the board to also consider the financial benefits to the companies who propose building solar farms and ask them if the projects are still viable if the government incentives are removed.

Mr. Andy Bowes said there is no battery size listed on page 21 and asked the Board to consider specifying size.

Ms. Bell said that is intentionally left out of this proposed law because if created it will be separate law.
