Assessor's Report:

Ms. Golden said 301 Change of Assessment notices were mailed the week of April 17, 2023.

Informal meetings with the Assessor were scheduled the week of April 24 and May 1st. A total of six informal appointments were scheduled. Grievance Day was held by appointment on Tuesday May 23. Five appointments were scheduled and 12 were paperwork only. The Town of Van Buren currently has no Small Claim filings for 2023. The deadline to file is August1st.

The Town of Van Buren has received no new Supreme Court filings for 2023. Current cases include Village Green Apartments filed each year 2018 – 2023, and Comfort Inn filed each year 2020-2023.

Ms. Golden said the Town of Van Buren Equalization Rate for the 2023 Assessment Roll is 95%. Onondaga County Equalization Rates for 2023 range from 1.55% to 100%. Three towns are at 100% (Dewitt, Manlius, Tully) the county average is 72%.

The Assessor's Annual Report has been completed and filed with the County and State as required by RPTL. A copy of page one is attached and indicates a net change in total assessed value from 2022 to 2023 of 8,547,409.

Ms. Golden said the following legislative changes were made:

State Solar and Wind Appraisal Model readopted for use in 2023. A temporary restraining order had been in place, due to a 2022 court case. Please note this occurred after the Tentative Assessment Roll was completed and no assessment challenges were made on Grievance Day.

Changes to the Senior Citizen and Limited Income Disability Exemptions. Redefines what is considered income and clarifies which income tax year applies. Gender-specific language was replaced and form updated.

HEREBY TAKE NOTICE that in accordance with Chapter 96, Article I of the Code of the Town of Van Buren, as amended, the Code Enforcement Officer for the Town of Van Buren has found the building owned by you and located at 1672 Old Route 31 in the Town of Van Buren, which property is designated as Tax Map No. 047.-01-08.0, to be dangerous or unsafe to the public and in violation of governing laws. A report from the Code Enforcement Officer, consisting of the Notice to Demolish dated May 10, 2023, with inspection analysis from Town Engineer Hoy and photographic evidence, has been presented to the Town of Van Buren Town Board with a request that the Town Board schedule a public hearing to consider the issuance of an order (1) deeming the aforementioned property to be a "dangerous" and "unsafe" to the public in accordance with Chapter 96 of the Town Code; and (2) directing the repair or removal of the building situated upon the property. Therefore, pursuant to Sections 96-3 and 96-4 of the Code of the Town of Van Buren, you are advised of the following:

- 1. **Description of the premises:** the subject premises is a single-family residential, "old style" structure located at 1672 Old State Route 31, in the Town of Van Buren, County of Onondaga, State of New York.
- 2. Statement of particulars in which said building is unsafe: the particulars are set forth in the materials, prepared by the Code Enforcement Officer, dated May 10, 2023, and attached collectively hereto as Schedule "A." As indicated in the attached Schedule "A," the particulars supporting the Code Enforcement Officer's determination that the building is in an unsafe condition and is dangerous to life, health, safety and general welfare of the public include, but are not limited to the extensive structural damage. More specifically, the roof of the structure has collapsed, the rear exterior wall has collapsed, the eastern wall is significantly out of plumb, and the foundation block wall on the east and south sides is structurally compromised; such deficiencies constitute a violation of the following sections of the New York State Property Maintenance Code: Sections 301, 302, 303, 304, 305, 306, 307, 308, 309, and 310; Sections 501, 502, 503, 504, 505, and 506; Sections 601, 602, 603, 604, 605, and 606; Sections 701, 702, 703, 704, and 705. It has further been opined that because 35% or more of the structure cannot be repaired and is unsafe to inhabit or occupancy.
- 3. Order: you are hereby ordered to commence efforts to make the structure safe and secure or, in the alternative, remove such structure, within 30 days of service of this notice and complete such efforts within 60 days thereafter.

- 4. Time and place of hearing: in case you, or such other persons having an interest in the property, wish to contest the order, the Town Board shall conduct a hearing and shall receive testimony and other evidence to determine whether the building is unsafe and constitutes a danger to the safety of the public. The hearing shall be held on Wednesday, August 2, 2023, at 7:00 p.m. or as soon thereafter as the matter can be heard at the Town Hall, 7575 Van Buren Road, Baldwinsville, New York. You shall be given the opportunity to be heard at the hearing, you may be represented by an attorney, and you may submit evidence on your own behalf. A copy of this notice shall be filed in the Onondaga County Clerk's Office, in the same manner as a notice of pendency pursuant to Article 65 of the Civil Practice Law and Rules.
- 5. Costs: in the event that the Town Board determines and declares that said building is unsafe and constitutes a danger to the public and you fail to contest the resulting order repair or remove and/or fail to comply with same, the Town Board may direct the Code Enforcement Officer to cause such building to be made safe and secure by such measures which may be reasonably necessary, or to have the building demolished and removed from the property. All costs and expenses incurred by the Town, including the cost of repair or removal and the cost of professional fees, shall be charged to and reimbursed by you as owner or shall be assessed against the land upon which said building is located.
- **6. Penalties:** Failure to comply with this notice may also subject you to any and all penalties available by law.
