Adoption of Local Law A-2018:

<u>079-18-030</u> The following resolution was offered by Ms. Sabin, who moved its adoption, seconded by Mr. Dudzinski to wit:

WHEREAS, pursuant to the provisions of the Municipal Home Rule Law, proposed Local Law A-2018, A Local Law Amending Chapter 200 of the Code of the Town of Van Buren titled "Zoning", was presented and introduced at a regular meeting of the Town Board of the Town of Van Buren held April 17, 2018; and

WHEREAS, a public hearing was held to consider said proposed Local Law No. A-2018 on May 1, 2018 by the Town Board of the Town of Van Buren and proof of publication of notice of such public hearing, as required by law, having been submitted and filed, and all persons desiring to be heard in connection with said proposed local law having been heard, and said proposed local law having been in the possession of the members of the Town Board of the Town of Van Buren in its final form in the manner required by Section 20 of the Municipal Home Rule of the State of New York; and

WHEREAS, at its April 17, 2018 meeting the Town Board determined that this proposed legislation is a Type II action for purposes of SEQR, thus concluding the environmental review process; and

WHEREAS, it is in the public interest to enact said Proposed Local Law No. A-2018.

NOW, THEREFORE, it is

RESOLVED AND DETERMINED, that the Town Board of the Town of Van Buren, Onondaga County, New York, does hereby enact Proposed Local Law No. A-2018 as Local Law No. 1-2018 as follows:

TOWN OF VAN BUREN LOCAL LAW NO. 1-2018

A LOCAL LAW AMENDING CHAPTER 200 OF

THE CODE OF THE TOWN OF VAN BUREN TITLED "ZONING"

BE IT ENACTED by the Town Board of the Town of Van Buren that this local law amends Chapter 200 of the Code of the Town of Van Buren, as follows:

<u>Section 1</u>. So that Section 200-9, titled "Word Usage; Terms Defined", is amended to add and amend the following definitions:

"Driveway: Land used by vehicular traffic as access to, and situated on, the property or lot, and shall be located within the Front Yard as determined either by the Town of Van Buren, New York State or Onondaga County Department of Transportation."

"Front Yard: Driveway access shall determine the Front Yard as an unoccupied space extending the full width of the lot between the front building line and the front lot line. In the case of a flag lot, the Front Yard is the unoccupied area between the building line and the point at which the access portion of the lot mergers with the regular portion of the lot."

Manufactured Home: Add a new subsection (4) as follows:

"(4) Allowed in manufactured home park only."

Mobile Home: Add a new subsection (1) (g) as follows:

"(g) Allowed in manufactured home park only."

Modular Home: Amend the first paragraph thereof so that it reads, in its entirety, as follows:

"(1) A factory-manufactured dwelling unit which is constructed by a method or system of construction whereby the structure or its components are wholly or in substantial part manufactured in a manufacturing facility, intended or designed for permanent installation, or assembly and permanent installation on a permanent foundation."

And adding a new subsection (2) as follows:

"(2) Allowed in any residential district."

And amending the definition of "Rear Lot Line" so that it reads in its entirety, as follows:

"Rear Lot Line: The lot line generally opposite the front lot line."

<u>Section 2.</u> Section 200-39, titled "Front Yard Regulations": Subsection E. titled "Yards on corner lots" is amended to read in its entirety, as follows:

"E. Only one front yard is required to comply with the minimum depth requirement, which shall be that yard abutting the more primary street as determined by the driveway address."

<u>Section 3.</u> So that Section 200-40 titled, "Side Yard Regulations" subsection B thereof is amended to read, in its entirety, as follows:

"B. Yards on corner lots. On corner lots, only one yard adjoining a street or right-of-way, either public or private, shall be considered a front yard. The other yard shall be considered a side yard. See Front Yard Definitions Section 200-9."

Section 4.

This Local Law shall take effect upon its filing with the New York Secretary of State.
