Action on Local Law C-2020 - Regulating Parking of Commercial Vehicles on Higgins Drive:

WHEREAS, pursuant to the provisions of the Municipal Home Rule Law, proposed Local Law C-2020, a "Local Law Amending Chapter 186 of the code of the Town of Van Buren titled "Vehicles and Traffic", with respect to parking limitations on Higgins Drive, was revised and reintroduced at a regular meeting of the Town Board of the Town of Van Buren held November 4, 2020 with amendments based on comments received from the public at the previous public hearing on October 20, 2020; and

WHEREAS, a public hearing was held to consider said revised and reintroduced proposed Local Law No. C-2020 on November 17, 2020 by the Town Board of the Town of Van Buren and proof of publication of notice of such public hearing, as required by law, having been submitted and filed, and all persons desiring to be heard in connection with said proposed local law having been heard, and said proposed local law having been in the possession of the members of the Town Board of the Town of Van Buren in its final form in the manner required by Section 20 of the Municipal Home Rule of the State of New York; and

**WHEREAS**, at its October 6, 2020 meeting the Town Board determined that this proposed legislation is a Type II action for purposes of SEQR, thus concluding the environmental review process; and

WHEREAS, it is in the public interest to enact said Proposed Local Law No. C-2020. NOW, THEREFORE, it is **RESOLVED AND DETERMINED**, that the Town Board of the Town of Van Buren, Onondaga County, New York, does hereby enact Proposed Local Law No. C-2020 as Local Law No. 3-2020 as follows:

### TOWN OF VAN BUREN LOCAL LAW NO. 3-2020

# A LOCAL LAW AMENDING CHAPTER 186 OF THE CODE OF THE TOWN OF VAN BUREN TITLED "VEHICLES AND TRAFFIC" WITH RESPECT TO PARKING LIMITATIONS ON HIGGINS DRIVE"

**BE IT ENACTED** by the Town Board of the Town of Van Buren that this local law amends Chapter 186 of the Code of the Town of Van Buren, as follows:

<u>Section 1</u>. The purpose of this local law is to enact parking restrictions for registered commercial class vehicles on Higgins Drive, a roadway located within the Town of Van Buren pursuant to the authority provided by Section 1660 of the New York Vehicle and Traffic Law.

**Section 2.** As authorized by §186-15 of the Code of the Town of Van Buren, so that Article VII, titled "Schedules", Schedule XI-- "Section 186-53 thereof, titled "Parking Prohibited at All Times", is amended to add a "no parking" zone for registered commercial class vehicles as follows:

Street Name	Direction	Location
Higgins Drive	Both	For registered commercial class vehicles (including any trailers, equipment or apparatus towed, hitched or used or capable of being towed, hitched or used in connection with said vehicle) from Village Blvd. North to cul-de-sac on Higgins Drive

<u>Section 3</u>. This local law is enacted pursuant to the authority granted to the Town in accordance with Section 10 of the Municipal Home Rule Law and the New York State Vehicle and Traffic Law, Section 1660.

### Section 4.
