## NOW, THEREFORE BE IT

**RESOLVED AND DETERMINED**, that the Town Board of the Town of Van Buren, Onondaga County, New York, does hereby enact Proposed Local Law No. G-2017 as Local Law No. 7-2017 as follows:

## TOWN OF VAN BUREN LOCAL LAW NO. 7-2017

A LOCAL LAW AMENDING CHAPTER 180, ARTICLE VIII
OF THE CODE OF THE TOWN OF VAN BUREN RELATING
TO THE TAX EXEMPTION FOR COLD WAR VETERANS IN ACCORDANCE

### WITH § 458-b OF THE NEW YORK REAL PROPERTY TAX LAW

**BE IT ENACTED** by the Town Board of the Town of Van Buren that this local law amends Chapter 180, Article VIII of the Code of the Town of Van Buren, as follows:

## **SECTION 1. PURPOSE AND INTENT**

The intent of this Local Law is to amend the Town of Van Buren Code provisions relating to a Cold War Veterans Tax Exemption to remove the 10-year limitation on this exemption, as authorized by Chapter 290 of the 2017 Session Laws of the State of New York which amended § 458-b of the New York Real Property Tax Law.

# SECTION 2. <u>ARTICLE VIII, SECTION 180-18 OF THE TOWN CODE IS AMENDED SO</u> THAT IT READS IN IT ENTIRETY AS FOLLOWS:

"The purpose of this article is to allow for a tax exemption for Cold War Veterans, allowable pursuant to § 458-b of the Real Property Tax Law of the State of New York, which was created by Chapter 655 of the Laws of the State of New York for the year 2007, as amended by Chapter 255 of the Laws of the State of New York for the year 2009 and Chapter 290 of the Laws of the State of New York for the year 2017."

# SECTION 3. SO THAT § 181-21B OF THE CODE OF THE TOWN OF VAN BUREN IS AMENDED, TO READ IN ITS ENTIRETY, AS FOLLOWS:

"B. The exemption provided in this Article shall apply to qualifying owners of qualifying real property, for so long as they remain qualifying owners."

## **SECTION 4. WHEN EFFECTIVE**

This local law shall take effect upon its filing with the New York Secretary of State.
