## Assessor's Report:

Ms. Golden said the 2016 state budget eliminated all new STAR exemptions starting with the 2016 assessment roll. Star exemptions are "grandfathered" for existing property owners with exemptions in place prior to 2016. New owners will register with DTF online or by phone for the Star Income Tax credit/check. Property owners will be required to pay their school tax bill in full and will receive the STAR savings by check from DTF. The Assessor's Office can no longer accept new STAR applications.

Ms. Golden said an updated spreadsheet for Floral Park owners has been completed and sent to ORPTS and the information will assist in processing STAR credit checks.

Ms. Golden said the town received no small claims or certiorari filings for 2017.

The County Clerk's office has updated to a new program which will effect deed processing by tax mapping and the Assessor's Office. She said the final deeds recorded under the old system are in the pipeline and the switch to the new system will begin shortly.

The State ORPTS is developing a new computer program to replace RPS V-4 and it is bring tested at locations across the state. No date has been set for a conversion at this time.

Ms. Golden said she worked with the Clerk/Tax Receiver's office to plan and implement mailing the STAR exemption renewals with the school tax bills. It was extra work for staff in both offices but will result in cost savings to the taxpayers.

Ms. Golden said she attended a week long training course in East Syracuse on Commercial/Industrial appraisal. The course was very informative and will county as 2 years of continuing education credit.
