Introduction and resolution to adopt town wide solar moratorium and set public hearing for April 6, 2022 at 7:00 pm:

Mrs. Van Der Water said it is better to review what we have in place and do our due diligence before any additional solar farms are located in town.

Ms. Sabin said when we originally approved the legislation we knew it was a changing technology and that the town would need to update it from time to time.

<u>043-22-030</u> Councilor Tupper introduced proposed Local Law No. A-2022 regarding imposing a twelve (12) month moratorium on the siting, placement, installation, construction, erection, and enlargement of Solar Farms within the Town of Van Buren and made the following Resolution, which was seconded by Councilor Lesniak

WHEREAS, this moratorium will enable the Town to address the growth in and changes to the solar industry since its enactment of regulations for "Solar Energy Systems," which are found in Article XV of Chapter 200, titled "Zoning," of the Code of the Town of Van Buren, while

the Town undertakes a review of its Comprehensive Plan and/ or land use regulations which are intended to, in part, address such new circumstances not addressed by its current law; and

WHEREAS, the Town Board has deemed this moratorium urgent and immediately necessary in order to preserve status quo while this issue is examined by the Town; and

WHEREAS, no other agency has the legal authority or jurisdiction to approve or directly undertake the enactment of Local Laws in the Town of Van Buren, such that there are no other involved agencies within the meaning of the New York State Environmental Quality Review Act (SEQR) with respect to the proposed enactment of said Local Law.

NOW, THEREFORE, it is

RESOLVED AND DETERMINED, that there are no other involved agencies, the Town Board shall act as lead agency, and that the enactment of this proposed local law, is a Type II action under SEQR, thus concluding the environmental review process; and it is further

RESOLVED AND DETERMINED, that the Town Board shall conduct a public hearing as to the enactment of proposed Local Law A-2022 at the Town of Van Buren Town Hall located at 7575 Van Buren Road, Baldwinsville, New York 13027 on April 6, 2022 at 7:00 p.m., or as soon thereafter as the matter can be heard, at which time all persons interested in the subject shall be heard; and it is further

RESOLVED AND DETERMINED, that pending action of this Local Law, the Town will neither accept nor process any application pertaining to Solar Farms.

Introduction of Local Law to update section 170 of Town Code to tighten town's written notice of highway defects:

<u>044-22-030</u> Councilor Lesniak introduced proposed Local Law No. B-2022 regarding amendment to the Code of the Town of Van Buren to update certain sections of the "Notification of Defects" provisions in the "Streets and Sidewalks" chapter of the Code and made the following Resolution, which was seconded by Councilor Van Der Water,

WHEREAS, proposed Local Law No. B-2022 has been introduced and will be considered for enactment pursuant to the provisions of the Municipal Home Rule Law; and

WHEREAS, Volume 6 N.Y.C.R.R., Section 617 of the Regulations relating to Article 8 of the New York State Environmental Conservation Law, requires that as early as possible after submission of a completed application, an involved agency shall make a determination whether a given action is subject to the aforementioned law; and

WHEREAS, no other agency has the legal authority or jurisdiction to approve or directly undertake the enactment of a local law in the Town of Van Buren, such that there are no other involved agencies within the meaning of the New York State Environmental Quality Review Act ("SEQR") with respect to the proposed enactment of said proposed Local Law, with the result that the Town Board shall act as lead agency in this matter; and

WHEREAS, the adoption of said Local Law is an unlisted action for purposes of environmental review under SEOR; and

WHEREAS, the Town Board has determined that a Short Environmental Assessment Form (EAF) shall be required in connection with this matter; and

WHEREAS, the said EAF has been prepared and has been reviewed by the Town Board; and

WHEREAS, the Town Board has considered the adoption of said Local Law, has considered the criteria contained in 6 N.Y.C.R.R. Part 617.7 and has compared the impacts which may be reasonably expected to result from the adoption of said Local Law against said criteria.

NOW, THEREFORE,

BE IT RESOLVED AND DETERMINED, that the enactment of this proposed local law is an unlisted action under SEQR, that there are no other involved agencies and the Town Board shall act as lead agency; and it is further

RESOLVED AND DETERMINED, that the Town Board has determined that this action shall have no significant adverse impact on the environment; that, accordingly, an environmental impact statement (EIS) shall not be required; and that this resolution shall constitute a negative declaration under SEQR; and it is further

RESOLVED AND DETERMINED, that the Town Board shall conduct a public hearing as to the enactment of proposed Local Law No. B-2022 at the Town Hall located at 7575 Van Buren Road in the Town of Van Buren on April ___, 2022, at 7:00 p.m., or as soon thereafter as the matter can be heard, at which time all persons interested in the subject shall be heard, at which time all persons interested in the subject shall be heard; and it is further
