Citizens Comments:

Mr. Andy Bowes said he has been riding his bike a lot this summer and fall and has noticed there is no striping on Crego Road or Tappan Street. He asked the Board to consider adding those since he relies on the line indicating the shoulder of the road. He also asked the Board to consider sidewalks for that area regardless of whether the Crego site is developed.

Mr. Ken Bush, County Legislator, wanted to update the Board on certain items approved in the \$1.4 Billion Dollar budget the County passed:

- \$5.5 Million to expand mental health services in schools
- \$1 Million in Capital Project money for senior centers
- \$5 Million for Main Street Re-Development

\$1 Million for home improvements for Veterans, an income based program \$100,000 for water chestnut control on the Seneca River

Mr. Jamie Rodems and Ruth Troy, representing the Canton Woods Senior Center addressed the Board. Mr. Rodems said he understands the pressure inflation is putting on the town budget but asked the Board to consider keeping their contribution to the center the same as the last ten years. He said they have not had an increase in contribution since 2012 when Onondaga County began paying for the Neighborhood Coordinator. Mr. Rodems said the budget at the center assumes a deficit and has run a deficit year after year. Money from the fundraising committee is used to close that gap.

Mrs. Van Der Water said the amount the town contributes to the center is staying the same for 2023. She said across multiple accounts the center has around \$160,000 in additional funds, even using only 50% of that amount to close the budget gap at an average of \$5,000.00 each year allows the center to keep a healthy endowment fund.

Ms. Lesniak said it would be helpful for the Board to know how many Van Buren residents use the center. Mr. Rodems said he will get that information to the Board and agrees they can do more outreach to get more seniors involved and using the center.

Ms. Troy thanked the Board for past support and not cutting the amount the center will receive in 2023.

WHEREAS, no other agency has the legal authority or jurisdiction to approve or directly undertake the enactment of a local law in the Town of Van Buren, such that there are no other involved agencies within the meaning of the New York State Environmental Quality Review Act (SEQR) with respect to the proposed enactment of said Local Law.

RESOLVED AND DETERMINED that there are no other involved agencies, the Town Board shall act as lead agency, and that the enactment of this proposed local law is a Type II action under SEQR, thus concluding the environmental review process; and be it further
